



Applicant Contract

This contract must be read by each child and their parent/guardian. Each child and their parent/guardian needs to initial each item and sign at the bottom. After completing the online application form, you must then email this contract to temeculakidsfair@gmail.com by March 2nd. **We need to receive one contract for each child at the booth.** Your application will not be considered complete unless the contract(s) is received by this date. All completed applications will be reviewed between March 2nd and March 4th. Final acceptance emails will be sent out no later than March 5th. Once you receive your acceptance email, the participation fee of \$40 will be due by March 7th. If the fee is not paid, your child(rens) application will not be complete and their spot will be offered to another participant.

- 1) Once payment is received, there will be NO refunds. _____
- 2) The fair is for children ages 6-14 years old at the time of the fair. _____
- 3) The fair will take place rain or shine. The outdoor booths will be under cover. _____
- 4) Each booth can have 1-3 children. Each booth can only have ONE business. _____
- 5) Booth assignments are determined by the hosts and are non-negotiable. Booth assignments will be given on the day of the fair at the check in table. _____
- 6) We will provide a 6 ft table for each booth. You may NOT bring an additional table. The participant will need to bring signage, price list, table covering, extension cords, chairs or anything else to showcase your business. Please make sure whatever you bring will fit right around your table so you don't interfere with the booth next to yours. _____
- 7) We only have electricity available for some booths due to limited availability. Electricity requests are only if your business requires it not if it is for decor. Your acceptance information will tell you if you were approved for electricity. You must supply extension cords. _____
- 8) We will have contests with cash prizes divided by age group. If multiple children are running a booth, they will be in the category of the oldest child. _____
- 9) Accepting paypal or venmo is permitted but must be managed by the kids. _____
- 10) All work related to the business must be done by the child(ren). For children 8 years and under, a parent may sit at the booth but may NOT run the booth. Parents may post on social media to advertise before the fair. Parents may help their children carry in and set up heavy items. Parents will then be asked to move away from the tables so the children can enjoy the experience of setting up their booths. If parents are seen to be interfering with their child's business, that business will be disqualified from the contest. _____
- 11) If you want/need to leave your stand, you can have another child run the stand for that time or have a sign that says be right back. Adults cannot run the stand at any time. _____
- 12) You may NOT add additional children to your booth after your application has been accepted. _____
- 13) Once all applications have been accepted, we will compile a list of the types of businesses that will be at our fair. This list will be emailed to you by March 8th and if your business has a lot of competition, you can change to a new idea that isn't on the list yet. New ideas will be approved first come, first served. Be sure to email us before making a new item and make sure someone else has not already added it. _____
- 14) After the final list of businesses has been compiled, you can only change or add a product if you get approval from us. We will not allow you to change or add a product that infringes on another pre-approved business. No additions or changes will be considered after April 6th. Booths with non-approved products will be disqualified from the contest. _____
- 15) Business names must be submitted by April 6th. _____
- 16) The fair will end at 4pm and we will need everyone to help clean up and move tables to a common area for the rental company to pick up. The award ceremony will take place after the clean up. _____
